2022 Community Days: A Month of Service

What: HCA Healthcare's Community Days: A Month of Service

When: October 1 - 31, 2022

Where: Middle Tennessee Nonprofits

How: Nonprofits can register to host HCA Healthcare specific in-person or virtual volunteer projects in our **Nonprofit Organizational Portal** (*Project registration will be open July 15 - August 15*)

While volunteering happens year round, HCA Healthcare colleagues are encouraged to volunteer in October with their favorite Middle Tennessee nonprofits. This year, we will open nonprofit project registration from July 15-August 15. During this time, nonprofits can register to host HCA Healthcare specific in-person or virtual volunteer projects. These projects can be held any day in October and can vary in group size and length of time. Each project is required to have a designated HCA Healthcare coordinator to work with your nonprofit on logistics, recruiting volunteers, and day of assistance. Please begin discussing this role with your HCA Healthcare volunteers, donors and board members. Any member of your organization can interact with the HCA Healthcare donation system at any time by accessing the Nonprofit Organization Portal at <https://nonprofit.yourcause.com>.

In the Nonprofit Organization Portal, you can:

- Access information about donors / gifts
- Sign up to receive distributions via ACH (rather than paper checks)
- Create volunteer projects for our colleague volunteering website
- Edit your logo, mission, contact information, etc.
- And, there's a dedicated help desk **available here**.

HCA Healthcare Colleague Board Service

While you are thinking about HCA Healthcare volunteers, remember that HCA Healthcare board members are essential to the relationship between a nonprofit, the HCA Healthcare Foundation and HCA Healthcare. Here are some suggested ways to identify a strong board candidate from HCA Healthcare.

- **Work with your current HCA Healthcare board member:** If your organization currently has an HCA Healthcare colleague serving on the board, it is never too early to work with them on cultivating a possible successor.
- **Post on the HCA Healthcare intranet:** Find out more about this process and submit your open positions on the **Nonprofit Board Leadership section** of the HCA Healthcare Foundation website. Placement is not guaranteed.
- **Engage other board members:** Let your entire board and supporter network know you are looking to actively recruit an HCA Healthcare colleague to join your board.
- **Reach out to current HCA Healthcare supporters:** Find donors to your organization through the **Nonprofit Organization Portal**.

Outcomes only required annually for HCA Healthcare Foundation grants

To further streamline the grant process, the HCA Healthcare Foundation is no longer requiring six and twelve month outcomes and impact reports. Instead, outcomes will now be a required question on an organization's annual grant application based on the grant type.

For example:

- **General Operating Grant:** Please describe the impact and measurable outcomes of your organization since you last applied for grant funding. Include quantitative as well as qualitative information in your answer.
- **Program Grant:** Please describe the impact and measurable outcomes of your program since you last applied for funding. Include quantitative as well as qualitative information in your answer.
