Nearly 4,500 of our local colleagues logged more than 57,000 hours of volunteer time, and 3,800 of our Middle Tennessee colleagues registered a charitable gift and activated an HCA Healthcare donation match.

### New grant acknowledgement process

Both the IRS and auditors require funders to keep acknowledgement letters on file to serve as receipts for grants awarded. The HCA Healthcare Foundation has implemented a new process to accept acknowledgements in our grantmaking system, eliminating the need for agencies to send a separate letter.

Please follow these instructions to access the acknowledgement form in your HCA Healthcare account:

# \*Note: You will need a copy of the grant award check to fill out and complete the acknowledgement form

- To access your account, please go to the Foundation website at <u>https://hcacaring.org/grants/middle-tennessee-fund.dot</u>.
- Under Grant Programs, select Access Existing Grants Application and click on Existing Applications.
- Once in your account, click on **Requirements** in upper left corner of the page. From the dropdown box on the upper right side of page, select **New Requirements**.
- Click on **Gift Acknowledgement Receipt**, fill in the blank fields, review and then submit your acknowledgement. From the review screen, you also have the option to print a copy for your records.
- After completion and submission, you should receive an acknowledgment email **please save this email for your records**.
- If you have any issues with logging-in or with the drop-down menu selection options, please <u>contact us</u>.

**User Tip:** When setting up a login and password for your account with the HCA Healthcare Foundation, it is best to create a generic email account (i.e. <u>grants@yournonprofit.org</u>). This will allow multiple people from the same organization access to the account for grant applications, as well as reporting requirements.

# Get a jump start on spring cleaning

#### Is your mailing address correct in Blackbaud?



To ensure your organization receives grant payments or other correspondence in a timely manner, we have added a second address option – **mailing address** – in addition to your primary physical address. Please ensure both addresses are correct in the Blackbaud system when submitting a grant application. The "mailing address" field can accommodate a Post Office Box (PO Box) option.
