HCA Healthcare Foundation and The Frist Foundation partner to fund over \$1M in safety and security grants

In a joint endeavor, the HCA Healthcare Foundation and The Frist Foundation recently awarded over \$1 million in grants to 24 childcare centers and place-based youth serving organizations. After the tragedy at the Covenant School in March, both foundations worked to develop a philanthropic response to meet specific needs related to physical safety and security. Both foundations were grateful for the opportunity to support these selected agencies' ability to conduct security assessments, implement physical security improvements and provide critical safety and first-aid trainings to staff.



Reminder: Required documents for grant applications

To ensure that your organization's grant application moves efficiently through the review process, please be sure to include all required documents when submitting your application. These include:

- **YTD Financials** – Profit & Loss or Income Statement is required (within the last 3 months). Must show most recent YTD income and expenses.
- **Current Operating Budget** – current fiscal year's budget.
- **Audited Financial Statements or 990** – must be for the most recently completed fiscal year. If audit or 990 for the most recent fiscal year is not available at the grant deadline, please let the grants team know.
- **Board List** – current list of members serving on the Board of Directors.
- **Strategic Plan** (over \$5k grants only) – most recent strategic plan document.
- **Project Budget** (if applicable) – specific to the program for which funds are being requested. Not applicable for operational support grants.

New grant acknowledgement process

For tax purposes, the IRS and auditors require funders to keep acknowledgement letters on file to serve as receipts. The HCA Healthcare Foundation has implemented a new process by which nonprofits receiving grant funding will now submit an acknowledgement form in the Blackbaud

system. The new acknowledgement form will appear on an organization's account as an Audit Requirement once a grant has been funded. This will eliminate the need for nonprofit agencies to send a separate letter and make it easier for the HCA Healthcare Foundation to ensure we have received an acknowledgement for every grant. We ask that agencies also save a copy of this form for their own records.

Agencies will receive an email if their grant is funded with directions and a link to access the acknowledgement form in their foundation account.

User Tip: When setting up a login/password to submit application, a generic email account is recommended (i.e. grants@abcnonprofit.org). By using a generic mailbox, multiple employees can use the same login and password.

Is your mailing address correct in Blackbaud?



To ensure your organization receives grant payments or other correspondence in a timely manner, we have added a second address option – **mailing address** – in addition to your primary physical address. Please ensure both addresses are correct in the Blackbaud system when submitting a grant application. The “mailing address” field can accommodate a Post Office Box (PO Box) option.
