New grant acknowledgement process

For tax purposes, the IRS and auditors require that funders keep acknowledgement letters on file to serve as receipts. The HCA Healthcare Foundation has implemented a new process by which nonprofits receiving grant funding will now submit an acknowledgement form in the Blackbaud system. The new acknowledgement form will appear on an organization's account as an Audit Requirement once a grant has been funded. This will eliminate the need for nonprofit agencies to send a separate letter and make it easier for the HCA Healthcare Foundation to ensure we have received an acknowledgement for every grant. We ask that agencies also save a copy of this form for their own records.

- Login to your grantrequest.com online account using the same email and password your organization used to submit its application.
- Once logged in, click the **Requirements** tab at the top left of the page.
- Use the drop-down menu on the right to select between: **New, In Progress** or **Submitted**.

User Tip: When setting up a login/password to submit application, a generic email account is recommended (i.e. grants@abcnonprofit.org). By using a generic mailbox, multiple employees can use the same login and password.

Is your mailing address correct in Blackbaud?



To ensure your organization receives grant payments or other correspondence in a timely manner, we have added a second address option – **mailing address** – in addition to your primary physical address. Please ensure both addresses are correct in the Blackbaud system when submitting a grant application. The “mailing address” field can accommodate a Post Office Box (PO Box) option.
